**NOTES:**

- In accordance with Constitution Rule 3: "Boat Affiliate, Associate, Intermediate, Junior, Country, Reciprocal and Service Members: Candidates for membership ... must be proposed and seconded by a Life Member, financial Ordinary Member or financial Country Member who must have been a member of the Club for at least one year.
- In accordance with Constitution Rule 5: "Ordinary Probationary Members: Candidates for Ordinary Probationary Membership may be proposed and seconded by a Life, financial Ordinary or financial Country Member who has been a member of the Club for at least one year. A candidate not proposed or seconded shall supply the names and addresses of two referees, who need not necessarily be members of the Club. Each referee shall submit a reference on behalf of the candidate.
- House Support Vouchers: A half-yearly charge of \$180 redeemable via membership swipe card is charged to all Ordinary, Family and reduced members each April and October. Any amount not expended by each charge date will be voided to a nil balance.
